2. If you are a firm, the application must be in the individual members' names.
3. The number of joint applicants may not exceed 4.
4. If you are a body corporate, the application must be signed by a duly authorised officer, who must state his representative capacity, and stamped with your corporation's chop.
5. You must be outside the United States, not be a United States Person (as defined in Regulation S under the U.S. Securities Act) and not be a legal or natural person of the PRC.
6. Unless permitted by the Listing Rules, you cannot apply for any Public Offer Shares if you are:
 - an existing beneficial owner of shares in the Company and/or any of its subsidiaries;
 - a Director or chief executive officer of the Company and/or any of its subsidiaries;
 - a core connected person of the Company or will become a core connected person of the Company immediately upon completion of the Share Offer;
 - a close associate of any of the above; or
 - have been allocated or have applied for any Placing Shares or otherwise participate in the Placing.

B. If you are a nominee

You, as a nominee, may make more than one application for the Public Offer Shares by: (i) giving electronic application instructions to HKSCC via Central Clearing and Settlement System ("CCASS") (if you are a CCASS Participant); or (ii) using a **WHITE** or **YELLOW** Application Form, and lodge more than one application in your own name on behalf of different beneficial owners.

C. Effect of completing and submitting this Application Form

By completing and submitting this Application Form, you (and if you are joint applicants, each of you jointly and severally) for yourself or as an agent or a nominee on behalf of each person for whom you act:

- undertake to execute all relevant documents and instruct and authorise the Company and/or the Joint Bookrunners (or their agents or nominees), as agents of the Company, to execute any documents for you and to do on your behalf all things necessary to register any Public Offer Shares allocated to you in your name as required by the Articles of Association;

D. Power of attorney

If your application is made by a person under a power of attorney, the Joint Bookrunners or their respective agents and nominees may accept or reject your application at their discretion, and on any conditions they think fit, including evidence of the attorney's authority.

Allocation of the Public Offer Shares — Pools A and B

There will be initially a total of 12,500,000 Public Offer Shares (after taking into account any reallocation of the number of Offer Shares allocated between the Public Offer and the Placing) to be offered for subscription by members of the public in Hong Kong under the Public Offer, representing approximately 10% of the total number of Offer Shares initially available under the Share Offer. For allocation purposes only, the 12,500,000 Shares initially being offered for subscription under the Public Offer (after taking into account any reallocation of the number of Offer Shares allocated between the Public Offer and the Placing) will be divided into two pools: Pool A comprising 6,250,000 Public Offer Shares and Pool B comprising 6,250,000 Public Offer Shares, both of which are available on a fair basis to successful applicants. All valid applications that have been received for Public Offer Shares with a total amount (excluding brokerage, SFC transaction levy, and the Stock Exchange trading fee thereon) of HK\$5 million or below will fall into Pool A and all valid applications that have been received for Public Offer Shares with a total amount (excluding brokerage, SFC transaction levy, and Stock Exchange trading fee) of over HK\$5 million and up to the total value of Pool B, will fall into Pool B. Applicants should be aware that applications in Pool A and in Pool B are likely to receive different allocation ratios. If Public Offer Shares in one pool (but not both pools) are undersubscribed, the surplus Public Offer Shares will be transferred to the other pool to satisfy demand in that other pool and be allocated accordingly. Applicants can only receive an allocation of Public Offer Shares from either Pool A or Pool B but not from both pools and may only apply for Public Offer Shares in either Pool A or Pool B. Any application made for more than 100% of the Public Offer Shares initially being available under Pool A or Pool B will be rejected. Multiple or suspected multiple applications and any application for more than 50% of the 12,500,000 Shares initially comprised in the Public Offer (that is, 6,250,000 Public Offer Shares) are liable to be rejected. Allocation of Offer Shares to investors under the Public Offer will be based solely on the level of valid applications received under the Public Offer. The basis of allocation may vary, depending on the number of Public Offer Shares validly applied for by applicants.
